Preamble :-

Ministry of Skill Development and Entrepreneurship, Government of India and Ministry of Human Resources and Social Security, People's Republic of China has bilaterally signed MoU for setting up "Mahatma Gandhi National Institute for Skill Development and Entrepreneurship" near Ahmedabad or some where in Gujarat, with mutual co-operation of China, during Hon'ble Chief Minister of Gujarat's visit of China from 14th May to 20th May, 2015.

Mahatma Gandhi Labour Institute (MGLI) is declared nodal agency vide Memorandum read as above, for setting up Mahatma Gandhi National Institute for Skill Development and Entrepreneurship in State of Gujarat.

"Mahatma Gandhi National Institute for Skill Development and Entrepreneurship" here in after shall be referred as to as "MGNISD&E" is develop as premier Institute at National and International level for Skill Development activities. MGNISD&E shall work as an organization for skills training accreditation, assessment and certification courses for various national and international students.

Government of Gujarat and Government of India have given high priority to skill development activities. Looking to the growth of Industrialization in Gujarat, Skill Training of National level shall be given in Gujarat. In view of above, setting up of MGNISD&E in Gujarat has been under consideration of the State government.

Resolution :-

The State Government is now pleased to resolve to Setting up the Mahatma Gandhi National Institute for Skill Development and Entrepreneurship (MGNISD&E) under Societies Act-1860 and Bombay Public Trust Act -1950 with following conditions and details mentioned below.

- (1) The name of the Institute shall be "Mahatma Gandhi National Institute for Skill Development and Entrepreneurship" hereinafter shall be referred to as "MGNISD&E".
- (2) The registered office of the MGNISD&E shall be situated initially in the state of Gujarat, at Mahatma Gandhi Labour Institute, Ahmedabad and later at any place within the State of Gujarat, as may be decided by the State Government

(3) Governing Body of MGNISD&E is constituted as under.

(4) Function and Power of Governing Body of MGNISD&E are as under.

- I. The Governing Body is empowered to do all acts and things that are incidental thereof for the day to day running of the "MGNISDE" subject to the regulation under the Societies Registration Act, 1960, and the Bombay Public Trust Act, 1950 and the relevant laws framed or to be framed by the Government from time to time;
- II. The Governing Body shall have the power of management and administration of the revenue and movable and immovable property of the "MGNISDE" and the conduct of all administrative affairs of the "MGNISDE" not otherwise provided for;
- III. To purchase, take on lease, hire or otherwise acquire or hold any immovable and / or movable property rights or privileges from the government, local body, from private party or to import and to improve and develop any property necessary convenient for the purpose of "MGNISDE";
- IV. To frame rules and regulations for the day to day management and functioning of the "MGNISDE" and delegate powers to executive committee, CEO and different authorities of "MGNISDE";
- V. Constitute Advisory Boards or Committees consisting of persons who need not, be members of the "MGNISDE" with such advisory functions the Governing Body may think proper;
- VI. To delegate any of its powers to the Member Secretary, other Committee Member or any other Officer, Employee or any other Authority of "MGNISDE";
- VII. To manage and regulate the finances, accounts, investment and property of the "MGNISDE" and all other affairs of the "MGNISDE" and to appoint such agents / advisors as may be considered fit;

- VIII. To create administrative, ministerial and other necessary posts based on the recommendation of Executive Committee and to specify the manner of appointment thereto;
- IX. To review and approve Budget Estimates;
- X. To sell, lease, mortgage or otherwise dispose of any property belonging to "MGNISDE", composite in the "MGNISDE" fund which does not consist of money for such consideration and upon such terms as the member in his discretion may deem fit and proper;
- XI. The Governing Body will have the power to co-opt from time to time for such period as they deem fit, representative or representatives of such other organizations or institutions and individuals as they deem desirable in the interest of the "MGNISDE". The co-opted member(s) shall have the right to participate in the discussion but not to vote.
- XII. To select non official members in both Governing Body and Executive Committee (EC) after recommendation of CEO or EC with reasons, The non-official members should be subject expert , persons with integrity and repute;

(5) Executive Committee of MGNISDE is constituted as under.

(6) Function and Power of Governing Body of MGNISDE are as follows.

The Executive Committee shall have the powers and responsibilities in respect of the following:

- (a) To frame regulations for the day to day activities of the MGNISDE
- (b) frame various policy & procedure to discharge functions of the MGNISDE
- I. Shall have powers to sanction capital and revenue expenditure within the financial limit approved by Governing Body;
 - II. Shall have powers to establish and spell out the membership of any other committees formed or taskforces / groups etc. for various areas of the skill building and entrepreneurship programme and decide with regards to their membership powers and functions.
 - III. Shall have powers to frame, amend or repeal Rules, Regulations, Standard Operating Procedures, Operational Manual, not changeable with this Bye-Laws, for the administration and management of the affairs of the "MGNISDE"

IV. The Executive Committee may delegate, to the Chairman, CEO, and or any of its members and / or to a committee/group or any other officer of the "MGNISDE" such administrative, financial and academic powers and impose such duties as it seems proper.

(7) MoA and Byelaws of MGNISD&E submitted by Director of Directorate of Employment and Training are approved with constitute Governing and Executive Body as pera 3 and 5 of this resolution

(8) One representative of Finance Department to be included in any other Committee constituted for MGNISD&E's expenditure and purchase,

(9)The following 7 Members from Governing Body is authorised for Registration and opening Bank Account in scheduled Bank for MGNISD&E.

(10) Objectives of MGNISD&E are as under

The "MGNISD&E" is envisaged as a fountain head of knowledge and high-end skill development which will institutionalize demand driven skill development system in the country to provide workplace-ready workforce to industry, trade and business. It is also envisaged as a center of excellence for creating hi-tech, innovative entrepreneurs through training, counseling, mentoring, and incubation.

The main objectives to be pursued by MGNISDE are :

- I. To promote, establish, set up, monitor and facilitate institutions and academies for the skills excellence standards that meet the demands of industry, trade and businesses through training methodologies and curricula and development of core entrepreneurial skills and competency standards that create skilled workforce and technology and innovation driven globally competitive entrepreneurs;
- II. To provide a common platform for collaboration amongst employers, training providers , the workforce and skill and jobseekers;
- III. To provide co-ordination, direction and guidelines for such academies/ institutions for excellence in skills and entrepreneurship development by acting as a premier national level institution;
- IV. To create communication interlinkages amongst partnering institutions which will include industry, trades, businesses, skilling, educational and research institutions and grass root mobilization organizations from public, private and Non-Governmental Organization for skill and entrepreneurship development;
- V. To assist in bridging skill and labour demand–supply asymmetries and creating a viable skill development chain, with particular emphasis on sectors where the market mechanism is ineffective or missing like the unorganized sector jobs;
- VI. To setup or to act as a facilitator for setting up specialized skilling centers to conduct sector specific or broad based multidisciplinary programmes in various Industrial and technical fields, directed towards world class training centers that

- cater to specialized, customized and high end training programmes in alignment with the industry, trade and business requirements across the globe;
- VII. To establish, manage, run and promote or facilitate to establish, manage, run and promote academies, institutes or centers of excellence to be set up by industries, trades, businesses, NGOs, NPOs and Government for imparting skills and entrepreneurship training in different sectors;
- VIII. To impart high level modular employable skill education, and/or certification and/or accreditation as it deems fit either by itself or associating, partnering, engaging or entering into joint venture and/or affiliating with State/ National/ International Institutions/Universities or in collaboration with the experienced or innovative practitioners from different fields, for the purpose of innovation and practice dissemination;
- IX. To promote a culture wherein entrepreneurship germinates and grows; and, to forge global trade and business linkages in a multi-stakeholder framework using a multi-disciplinary approach; and foster and facilitate innovation driven hi-tech entrepreneurship to augment the startup process;
- X. To make special efforts for promoting entrepreneurship among women, Scheduled Caste, Scheduled Tribe and other marginalized communities to diversify the sources of entrepreneurial supply and, thus, make the efforts inclusive;
- XI. To promote social entrepreneurship and impact investing in order to serve the underserved markets and address the needs of the people at the bottom of the pyramid.
- (11) The Governing Body shall meet at least once in every year and a copy of the proceedings note of the meeting shall be submitted to Government.
- (12) The Executive Committee shall conduct meeting at least once in a quarter and a copy of the proceedings note of the meeting shall be submitted to Government.
- (13) The expense of registration and opening bank account of MGNISD&E shall be debited from MGLI.
- (14) Proposal to deposit ₹1.00 Crore into MGNSD&E's bank account shall be send to the Department for approval of F.D for the provision made in the 2016-17 budget.
- (15) To meet the expenditure for the next year , New Item for the 2017-18 will be submitted under Budget Head D.No-57 ,2230-03-101-xx. (xx opening new sub head)
- (16) The expenditure shall be debited from the Budget Head D.No-57–2230-01-800-01 , Detailed head 3135.
